INSURANCE

It is also required that each Clean & Green group has liability insurance to cover every individual performing work as well as the Genesee County Land Bank or that each participant sign a liability release form (parents or guardians will be required to sign liability release forms for youth participants). Groups selected for the 2011 program will have to provide proof of insurance or commit to liability release forms in order to participate.

YOUR CLEAN & GREEN PROPOSAL

All Clean & Green participants will be responsible for cleaning and mowing at least 25 Land Bank-owned properties every three weeks (from May to September). Please provide a detailed description of how your group would maintain properties through the Clean & Green program; what is your maintenance plan? Some questions to consider are: What is the size of your maintenance group? How does your maintenance group work together? What kind of equipment do you have? What other resources do you have? What ideas do you have for cleaning and maintaining the land? What other interesting information can you share about
