**All properties are transferred with a QUIT CLAIM DEED once purchase is paid in full. The GCLBA does not provide title insurance. If title insurance is desired it will be the responsibility of the Purchaser. The purchaser MUST Coordinate with and obtain all permits and inspections required by the local unit of government, to carry out the necessary improvements to BRING THE PROPERTY UP TO CODE. All property is sold AS IS.**
