REQUEST FOR PROPOSALS – FORESTRY SERVICES

INTRODUCTION

A. Overview

This Request for Proposals ("RFP") is being issued by Genesee County Land Bank Authority ("GCLBA"). GCLBA invites the submissions of proposals for a Professional Firm to provide Forestry Services for the removal and pruning of trees on GCLBA property within the City of Flint and Genesee County, Michigan.

Forestry Services will involve complete removal of identified trees, including restoration services, pruning of identified trees and removal of existing limbs, logs, brush, etc. After currently identified trees have all been removed or pruned, Forestry Services shall be performed in a batch-basis as more trees are assessed for removal or pruning. Please see **Supplement C** for currently identified trees.

Professional Firms that provide Forestry Services must be licensed to operate and conduct business in the state of Michigan. GCLBA encourages participation by respondents who are MBE/WBE.

Nothing in this RFP shall be construed to create any legal obligation on the part of GCLBA or any respondents. GCLBA reserves the right, in its sole discretion, to amend, suspend, terminate, or reissue this RFP in whole or in part, at any stage. In no event shall GCLBA be liable to respondents for any cost or damages incurred in connection with the RFP process, including but not limited to, any and all costs of preparing a response to this RFP or any other costs incurred in reliance on this RFP. No respondent shall be entitled to repayment from GCLBA for any costs, expenses or fees related to this RFP. All supporting documentation submitted in response to this RFP will become the property of the GCLBA. Respondents may also withdraw their interest in the RFP, in writing, at any point in time as more information becomes known.

Each proposer is responsible for labeling the exterior of the sealed envelope containing the proposal response with the proposal number, proposal name, proposal due date and time, and your firm's name. The proposal request number and due date for this Bid is:

B. RFP Modifications

The GCLBA has the right to correct, modify or cancel the RFP, in whole or in part, or to reject any Bid, in whole or in part, within the discretion of the Genesee County Land Bank Authority, or their designee. If any such changes are made, all known recipients of the RFP will be sent a copy of such changes. If any changes are made to this RFP document by any party other than GCLBA, the original document in the GCLBA's files takes precedence.

C. Contract Award/Split Award

The GCLBA reserves the right to award by item and/or group of items. The GCLBA also reserves the right to choose a single Professional Firm to carry out General Contracting duties and to sub-contract other aspects of the work needed for this project. The Bidder(s) to whom the award is made will be notified at the earliest possible date. Tentative acceptance of the bid, intent to recommend award of a contract and actual award of the contract will be provided by written notice sent to the Bidder(s) at the address designated in the bid if a separate Agreement is required to be executed. After a final award of the Agreement by the GCLBA, the Contractor/Vendor must execute and perform said Agreement. All proposals must be valid for at least 120 days from the due date of the proposal. If, for any reason, a contract is not executed with the selected Bidder within 14 days after notice of recommendation for award, then GCLBA may recommend the next lowest responsive and responsible Bidder.

D. Time of Completion

Any agreements awarded pursuant to this RFP solicitation shall be in accordance with the scope of work and compensation as outlined below, and, within a mutually agreed upon expedited timeframe.

E. Term of Service

Any Professional Firms providing Forestry Services selected as a result of this RFP solicitation shall provide services to GCLBA for a through the end of 2025.

F. Compensation for Inspected & Finalized Work

GCLBA shall compensate the awarded contractor(s) in a mutually agreed upon batch format. Invoices received from the contractor(s) shall reflect the agreed compensation format.

G. Background

The Land Bank's mission is to restore value to the community by acquiring, developing and selling vacant and abandoned properties in cooperation with stakeholders who value responsible land ownership.

The GCLBA acquires properties through the tax foreclosure process. All tax foreclosed properties that go unsold through public auction and are not accepted by the state or local unit of government are transferred from the County Treasurer to the GCLBA. Once properties are under the ownership of the GCLBA, they can be sold on a case-by-case basis. The GCLBA may also do some rehabilitation work on some of the properties it acquires.

The GCLBA also completes some demolitions when grant funding allows helping clean up blight in the community.

PROFESSIONAL SERVICE REQUIREMENTS

A. Scope of Work

GCLBA is in need of a Professional Firm to provide Forestry Services to remove and prune trees currently identified on GCLBA property across the City of Flint and Genesee County. We hold a backlog of 300+ tree complaints that have been assessed by our partners with the Genesee Conservation District for removal or pruning. GCLBA aims to address all of the identified trees by the end of 2024 and will continue to address tree related complaints as they are filed moving forward. Continuing Forestry Services will be required through the end of 2025 as more trees are identified and will be submitted to the chosen firm for action in a mutually agreed upon batch format for efficiency purposes.

Services requested shall include but are not limited to:

- Complete removal of identified trees
- 2. Proper disposal of tree debris
- 3. Stump grinding (where appropriate)
- 4. Restoration of work site (backfill, leveling)
- Limb pruning of identified trees
- 6. General removal of existing debris (limbs, logs, stumps, brush, etc.)

B. Compensation

All proposals shall include per DBH inch for each specified service, in addition to other specified services.

EVALUATION CRITERIA AND SCORING

In evaluating responses to this Request for Proposal, GCLBA will take into consideration the experience, capacity, and costs that are being proposed by the Respondent. The following Evaluation Criteria will be considered in reviewing submittals:

A. Experience and Capacity

The point system is to evaluate the experience and capacity of the Respondent.

1. Experience in Professional Forestry Services:

(30 points total)

SUBMITTAL REQUIREMENTS

RFP responses should be submitted via email in PDF format. Responses may be submitted in hard copy, but email is the preferred method. Each respondent shall submit one (1) copy of the following documents in a clear, legible font 11pt or larger, and 8.5 by 11 inch format. Respondents are advised to adhere to the Submittal Requirements. Failure to comply with the instructions of this RFP will be cause for rejection of submittals.

GCLBA reserves the right to seek additional information to clarify responses to this RFP. Each response must include the following:

A. Letter of Interest

Please submit a Cover Letter of Interest signed by a duly authorized officer or representative of the Respondent, <u>not to exceed two pages in length</u>. The Letter of Interest must also include the following information:

- 1. The principal place of business and the contact person, title, telephone/fax numbers and email address.
- 2. A brief summary of the qualifications of the Respondent and team.
- 3. Description of organization (i.e. Corporation, Limited Liability Company, or Joint Venture).
- 4. The names and business addresses of all Principals of the Respondent. For purposes of this RFP "Principals" shall mean persons possessing an ownership interest in the Respondent.

- 5. If the Respondent is a partially owned or fully-owned subsidiary of another organization, identify the parent organization and describe the nature and extent of the parent organization's approval rights, if any, over the activities of the Respondent.
- 6. If the Respondent is a partially owned or fully-owned subsidiary of another organization, identify the parent organization and describe the nature and extent of the parent organization's approval rights, if any, over the activities of the Respondent.

B. Threshold Requirements

These documents must be submitted and acceptable before GCLBA will review the Experience and Capacity proposal:

- 4. <u>Evidence of Financial Stability</u>: All Respondents shall include their most recent financial statements with the proposal response. This information will assist GCLBA in determining the Respondent's financial condition. GCLBA is seeking this information to ensure that the proposer's have the financial stability and wherewithal to assure good faith performance.
- 5. Three (3) references of related projects, including date of project, contact person and phone number, and a brief description of the project.
- 6. <u>Conflict of Interest Statement & Supporting Documentation:</u> Respondent shall disclose any professional or personal financial interests that may be a conflict of interest in representing the GCLBA. In addition, all Respondents shall further disclose arrangement to derive additional compensation from various investment and reinvestment products, including financial contracts.
- 7. <u>Certification Form Note and Signature Page</u> attached hereto at the end of this RFP and incorporated herein by reference must be signed by Respondent and attached to the Letter of Interest. Additionally, at least one of the proposals submitted is to include an **original signature** of an official authorized to bind the proposer to the proposal response.

C. Main Proposal

- Compensation All proposals shall include a fee schedule for each service.

SELECTION PROCESS

The Selection Committee comprised of GCLBA staff will review qualifications in accordance with the evaluation criteria set forth herein. Proposals that are submitted timely and comply with the mandatory requirements of the RFP will be evaluated in accordance with the terms of the RFP. Any contract resulting from this RFP will not necessarily be awarded to the vendor with the lowest price. Instead, a contract shall be awarded to the vendor(s) whose proposal received the most points in accordance with criteria set forth in RFP.

The Selection Committee may select multiple Professional Forestry Services Companies to enter into a contract with depending on the resources provided in bid documents.

SUPPLEMENT A:

A. General Requirements/Expectations:

- 1. The Contractor shall be required to post "NO PARKING" signs in areas where work will take place one (1) day prior to commencing work. Areas will be posted once and completed before starting another area. Signs shall be removed upon completion and used again for another area.
- 2. The Contractor shall be required to notify Jason Jospeh, Facilities Manager, GCLBA (810) 257-3088 x 589, of any change to established work schedules.
- 3. Work shall not start before 7:00 a.m. and shall end no later than dusk of 6:00 p.m. Monday through Saturday.
- 4. All work performed must follow current ANSI A300 and ANSI Z133 standards.
- 5. Equipment shall be operated in a safe and prudent manner in accordance with all Federal, State (MIOSHA), County and Local Ordinances. Vendors must provide a list of equipment with their proposal.
- Safety precautions shall be practiced by the Contractor to adequately safeguard all persons and property from injury or damage. All federal, State (MIOSHA), County, and local ordinances shall apply.
- 7. Contractor must give a 24-hour prior notification to adjacent property owner(s) of any pruning or removals.
- 8. Clean-up and disposal of all pruning and tree debris, including chipping debris shall be the responsibility of the Contractor. All work sites shall be left clean and free of debris at the end of each workday. If debris is evident on sidewalks, curbs, gutters and pavement areas, they should be left in a "broom cleaned" condition upon completion of work each day.
- 9. Existing brush and/or logs larger than 2" in diameter shall be removed and properly disposed of.
- 10. Contractor shall furnish all necessary supervision, laborers, vehicles and equipment capable of effective and efficient pruning/removal of specified trees. In addition, the Contractor shall maintain onsite at all times work is being performed, a site supervisor who represents the Contractor and can adequately communicate with the GCLBA representative both orally and in writing.
- 11. A Final Inspection of each tree removed or trimmed will be conducted by the GCLBA or a Project Partner.

B. Removal Requirements:

- 1. All trees removed must have stumps ground down 6" 8" below grade if logistically possible and all chips must be removed. Chip removal is the responsibility of the tree Contractor. Wood chips shall be transferred to a local designated site.
- 2. Please price separately for stump removal and restoration services (stump grinding, backfill).

C. Restoration Requirements:

After tree removal has been completed, restorative care shall be performed. This is to include stump grinding, and depressions filled with compacted topsoil.

- Topsoil: Backfill soil shall be screened and be mounded 2-3 inches to account for settling.
- 2. Hardwood trees: Any hardwood trees removed that are good candidates for reuse may be left at the site. GCLBA will identify which trees to leave at the site for reuse and will communicate that with the selected Firm(s) prior to work commencing.

D. Pruning Requirements:

Not all areas require pruning for height. Branching habit, broken and storm damaged limbs, suckers, water sprouts and deadwood are to be removed or corrected on every tree on the assigned list of identified trees according to the following:

- 1. Remove all dead limbs and branches, "hangers", suckers, water sprouts and broken or interfering branches. Flush cut all stubs at the branch collar.
- 2. Trees requiring the removal of lower branches shall be trimmed in a manner as to keep the normal balance of height and width by selectively removing branches and limbs.
- 3. Raise lower branches to obtain the following clearance heights. Trim height may vary depending upon species of tree. Any variance is to be approved by the GCLBA Facilities Manager and Property Manager.
 - A. Clearance over curbs and streets 15 feet
 - B. Clearance over lawns, walks and drives 15 feet
 - C. Clearance from roofs and structures 15 feet
 - D. Provide clearance of all street lighting utility lines

E. Public Relations:

The Contractor and their employees shall conduct themselves in a respectful and courteous manner if interacting with the public.
